1. Responsible office, Person responsible;

2. Personal data

Personal data is any such information that is clearly related or attributable to a particular natural person. 3.2. Cookies

5. Your rights

Information right

This right applies with effect for the future; the legality of the data collected until the revocation remains unaffected. You can exercise your right of withdrawal at any time. Right to data portability

You have the right to request a transfer of your data from us to another location.

Right to rectification, cancellation or blocking

You have the right to have your data corrected, deleted or blocked. The latter applies if the legal situation does not permit deletion.

Contradiction right

Insofar as your data are processed on the basis of legitimate interests in accordance with Art. 6 (1) (f) DSGVO, you have the right to object to the processing of your personal data if there are reasons for this arising from your particular situation.
